#### 3. Type of Allocation of Quota Places

Quota places will be allocated to the NOC.

### C. Eligibility

### Athlete Eligibility

Only those athletes who have complied with the Olympic Charter (at all times) may participate in the European Games. For the sake of clarity, all athletes must comply with the provisions of the Olympic Charter in force during the qualification period for the European Games up until the end of the period of the European Games.

#### Age Requirements

All athletes participating in the Baku 2015 European Games must be born on/or before 31 December 1996. Athletes born between 01 January 1997 and 31 December 1997 will have to provide a medical certificate and authorisation of a parent or legal guardian to FILA.

#### **Medical and Anti-Doping Requirements**

To be eligible to participate in the Baku 2015 European Games, all athletes must satisfy the medical requirements according to FILA Health Regulations

To be eligible to participate in the Baku 2015 European Games, all athletes must undergo antidoping controls in accordance with the FILA and WADA Anti-Doping Rules

#### **Additional EF Requirements**

To be eligible to participate in the Baku 2015 European Games, all athletes must comply with all conditions within the FILA Regulations, especially hold a valid license issued by their National Federation and be recorded in FILA's Official database.

### **D.** Qualification Process

The 2015 Senior European Wrestling Championships will be incorporated into the Baku 2015 European Games as the Wrestling competition events.



The Senior European Wrestling Championships is an open event. However the overall athlete quota of 400 cannot be exceeded.

FILA shall use entries confirmed at the 2014 Senior European Championship as the basis of NOC quota allocation for the Baku 2015 European Games.

### Host NOC Allocation

**Allocation Process** 

The Host NOC is guaranteed

- 12 Places in the Men's Events (1 in each weight category)
- 6 Place in the Women's Events(1 in each weight category)

### Universality

**Allocation Numbers** 

2 Male Universality places are made available to eligible NOCs at the Baku 2015 European Games

2 Female Universality places are made available to eligible NOCs at the Baku 2015 European Games

### E. Confirmation process for Quota Places

BEGOC on behalf of FILA will inform NOCs in writing on 1 June 2014 of the athlete quota places they could use.

Eligible NOCs must inform BEGOC and FILA in writing by 31 July 2014 whether or not they intend to participate at the European Games.

By 1 September 2014 FILA will reallocate all available quota places

### F. Reallocation of unused quota places

Should an NOC return an athlete quota place that has been obtained, the next best ranked NOC, not yet qualified, will be allocated the athlete quota place. This process will be repeated until all places are allocated.



## G. Qualification Timeline

01 September 2014	FILA to reallocate all unused quota places
01 May 2015	Deadline for BEGOC to receive entry forms submitted by the NOCs

## H. 2016 Olympic Qualification

In order to participate in the first qualification phase for the 2016 Olympic Games (2015 Senior World Championship), the NOC must enter for the 2015 European Games at least the same number of wrestlers than they want to enter for the 2015 Senior World Championship.
