### C. Athlete Eligibility

ATHLETE ELIGIBILITY
<p>All athletes must comply with the provisions of the Olympic Charter currently in force and only those athletes who have complied with the Olympic Charter may participate in the Youth Olympic Games.</p> <p>To be eligible to participate in the Youth Olympic Games, athletes must be born between 1 January 1996 and 31 December 1997.</p> <p>Only boxers who have competed at AIBA Youth World Championships and in the AIBA Women's Youth Olympic Qualifying Event are eligible to compete at the Youth Olympic Games.</p> <p>Boxers must satisfy the nationality and medical requirements to compete, according to the AIBA Technical and Competition Rules.</p>

**D. Qualification System****QUALIFICATION PATHWAY**

For each qualifying event, the qualification places obtained for the Youth Olympic Games will be allocated to:

**62 Qualification places:**

The only qualifying events will be:

- For men, the AIBA Youth World Boxing Championships which will be held in April 2014.
- For women, the AIBA Women's Youth Olympic Qualifying Event which will be held at the same time as the AIBA Youth World Boxing Championships in April 2014.

**Men**

The first five (5) men boxers from different NOCs in each weight category will qualify for the YOG.

The allocation of qualification places from the AIBA Youth World Boxing Championships is limited to a maximum of three (3) boxers per country/NOC. In the event of one country winning more than three (3) qualification places at the AIBA Youth World Boxing Championships, the country must select its final choice of three (3) athletes (1 boxer per weight category) within the given deadline.

**Women**

The first four (4) women boxers from different NOCs in each weight category will qualify for the YOG.

The allocation of qualification places from the AIBA Women's Youth Olympic Qualifying Event is limited to a maximum of two (2) boxers per country/NOC. In the event of one country winning more than two (2) qualification places at the AIBA Women's Youth Olympic Qualifying Event, the country must select its final choice of two (2) boxers (1 boxer per weight category) within the given deadline.

**HOST COUNTRY REPRESENTATION****2 Host Country Places:**

Two (2) places (one [1] man and one [1] woman) will be reserved for the host country. The host country must make its final choice for these two (2) places two (2) weeks after the AIBA Youth World Boxing Championships and AIBA Women's Youth Olympic Qualifying Event.

**UNIVERSALITY PLACES****14 Universality Places:**

To be eligible to receive Universality Places, athletes must comply with the eligibility criteria as defined under point C. of this document.

14 Universality Places will be allocated to NOCs by the YOG Tripartite Commission in March 2013 in collaboration with AIBA, if the technical level of the athletes allows it.

NOCs which will be awarded Universality Places will have to compete in the AIBA Youth World Boxing Championships and/or AIBA Women's Youth Olympic Qualifying Event to validate the use of their Universality Places.

The final confirmation of allocation of these 14 Universality Places will be made to athletes by the YOG Tripartite Commission in June 2014.

## E. Confirmation process for quota places

CONFIRMATION PROCESS FOR QUALIFICATION PLACES
<p>AIBA shall confirm qualified athletes to NOCs immediately following each qualifying event.</p> <p>NOCs will then have up to two (2) weeks from the day of the email/letter to confirm in writing (via official letter including names and weight categories of each boxer) to AIBA and NYOGOC that they will use the obtained places.</p> <p>NOCs which have qualified more than three (3) men and/or two (2) women will also have up to two weeks from the day of AIBA's confirmation email/letter to confirm the athletes they have selected (3 men and/or 2 women, 1 boxer per weight category) in writing (via official letter including names and weight categories of each boxer) to AIBA and the NYOGOC.</p>
CONFIRMATION PROCESS FOR HOST COUNTRY PLACES
<p>The host country must make its final choice for these two (2) places two weeks after the AIBA Youth World Boxing Championships.</p> <p>The host country must advise AIBA of its decisions, via official written letter, including names and weight categories of each boxer.</p>

## F. Reallocation of unused quota places

REALLOCATION OF UNUSED QUALIFICATION PLACES
<p>If, for any reason, an NOC decides not to use a qualification place obtained during the AIBA Youth World Boxing Championships and the AIBA Women's Youth Olympic Qualifying Event, the place will be reallocated to the next best ranked boxer(s) in the respective weight category at the AIBA Youth World Boxing Championships or the AIBA Women's Youth Olympic Qualifying Event</p>
REALLOCATION OF UNUSED HOST COUNTRY PLACES
<p>Any unused host country places will be reallocated to the next best ranked boxer(s) in the respective weight category at the AIBA Youth World Boxing Championships or the AIBA Women's Youth Olympic Qualifying Event</p>
REALLOCATION OF UNUSED UNIVERSALITY PLACES
<p>Any unused Universality Places, including those returned after the final allocation by the YOG Tripartite Commission, will be reallocated according to the next best ranked boxer in the respective weight category at the AIBA Youth World Boxing Championships or the AIBA Women's Youth Olympic Qualifying Event.</p>
