C. Athlete Eligibility

ATHLETE ELIGIBILITY
<p>All athletes must comply with the provisions of the Olympic Charter currently in force and only those athletes who have complied with the Olympic Charter may participate in the Youth Olympic Games.</p> <p>To be eligible to participate in the Youth Olympic Games, athletes must be born between 1 January 1996 and 31 December 1998 and must have taken part in the dedicated qualification event (including candidates for NOC Universality Places).</p>

D. Qualification System

QUALIFICATION PATHWAY
<p>For each qualifying event, the quota places obtained for the Youth Olympic Games will be allocated to:</p> <p><input type="checkbox"/> Athletes</p> <p><input checked="" type="checkbox"/> NOC</p> <p>A dedicated qualification event for the YOG will be held no later than April 2014. The date and location of this event will be confirmed by FINA following the selection of the host country and federation.</p> <p>Only for the qualification phase, an NOC may enter one (1) diver in each of the four (4) individual events.</p>

For individual events:
The top 9 finishers at the qualifying event will obtain a qualification place for their respective NOC.

For the team event:

- a) a team comprising one (1) male and one (1) female diver amongst those qualified through the individual events;
- b) a team may be composed of two athletes from the same NOC.
- c) FINA may decide on additional teams to compete, made up of athletes from different NOCs in accordance with the event ranking.

HOST COUNTRY REPRESENTATION

The host NOC will have the right to enter four (4) athletes, one (1) diver per individual event, who shall be required to participate in the qualification event.

UNIVERSALITY PLACES

To be eligible to receive Universality Places, athletes must comply with the eligibility criteria as defined under point C of this document.

There will be 2 Universality Places for each individual event, for a total of 8 Universality Places.

E. Confirmation process for quota places

CONFIRMATION PROCESS FOR QUALIFICATION PLACES

FINA shall confirm qualified athletes and teams to NOCs immediately following the qualifying event.

NOCs will then have up to two weeks to confirm in writing to FINA and the Nanjing Organising Committee that they will use the places obtained.

CONFIRMATION PROCESS FOR HOST COUNTRY PLACES

The use of the host country places must be confirmed by 8 June 2014.

The entries by name will then have to be submitted by 8 July 2014.

F. Reallocation of unused quota places

REALLOCATION OF UNUSED IF QUALIFICATION PLACES

Should an NOC choose not to use a qualification place, any unused places will be reallocated to the NOCs of the next best ranked divers at the dedicated qualification event.

REALLOCATION OF UNUSED HOST COUNTRY PLACES

If the host country has no eligible divers to fill its reserved quota, then the unused places will be reallocated to the NOCs of the next best ranked divers not yet qualified at the dedicated qualification event.

REALLOCATION OF UNUSED NOC UNIVERSALITY PLACES

Any unused NOC Universality Places, including those returned after the final allocation by the YOG Tripartite Commission, will be reallocated to the NOCs of the next best ranked divers not yet qualified at the dedicated qualification event.

G. Qualification timeline

DATE	MILESTONE
March 2013	Validation of final allocation of Universality Places by the YOG Tripartite Commission
February – April 2014	Qualification event FINA to confirm to the NOCs the qualified athletes and teams immediately following the qualifying event.
Two weeks after FINA sends confirmation to NOCs	NOCs to confirm in writing to FINA and the Nanjing Organising Committee the use of the places obtained.
8 June 2014	Deadline for the host country to confirm the use of its places
8 July 2014	Entries deadline by name for all sports
16 - 28 August 2014	2 nd Summer Youth Olympic Games – Nanjing 2014
